

Davidson County Chancery Court Filing Fees

Effective January 1, 2026

Fees in civil cases should be paid in advance unless otherwise specified by statute.
Fees for initiation of a new case include \$25.75 state litigation tax and \$33.75 county litigation tax.
Payment remitted to the Clerk & Master must be drawn on a United States bank or credit union.
Credit/debit card payments are accepted via our online payment portal and in person.
